Product Features

- A concentrate designed to be used through the Easidose pump.
- Particularly suitable for use in food preparation areas.
- Easily cuts through grease and grime
- Passes BS EN 1276:2009 at 1:10 dilution
- Kills 99.999% of germs with a contact time of 5 minutes

Direction for Use

- Dilute with water at 3 pumps per 750ml trigger bottle or 5 pumps per 10 Litre Bucket.
- On walls and surfaces : Use via a trigger spray
- Spray on to a clean damp cloth and apply to surfaces.
- Pay particular attention to corners, edges and underneath shelves and surfaces.
- Leave for 5 minutes then wipe with a damp clean cloth and rinse well.
- Wipe off with a clean damp cloth or paper towel.
- On Floors : Sweep floor thoroughly
- Wash floors using a clean mop and bucket of solution
- Rinse with clean water and allow to dry.
- Rinse out mop.
- **Regulation (EC) No 396/2005 Maximum Residue Levels. The biocide in this product (Benzalkonium Chloride) has an MRL of 0.1ppm. And therefore food preparation surfaces must be rinsed thoroughly with clean water after disinfection.**

Shelf Life

- Shelf life 24 months, if stored as recommended.
- Use within 6 months of opening.

Storage

- Store in cool conditions away from direct sources of heat
- Avoid extremes of temperature
- Do not allow to freeze
- Ensure the cap is tightly fitted after use
